- O **Settlement Statements** for a home sale, refinance, or 2nd mortgage
- Vehicle License Tab payments
- O Form 1098 (Mortgage Interest Statement)
- Charitable Contribution Receipts (receipt for every contribution, regardless of amount)
- O **Description of Non-Cash Contributions** for each gift when the total for the year is greater than \$500
- **O** Investment Interest Expense
- O Gambling Expenses to the extent of Gambling Income

Miscellaneous

- O Childcare Expenses and provider information
- O Tax Notices received from the IRS or other taxing authority
- Adoption Expenses
- O **Alimony** paid or received under a pre-2019 agreement
- O **Rental Property / Business** Income and Expenses
- O Contributions to a 529 Savings Plan (Account Number, Brokerage Company, Amount)
